IN SERVICE OF THIS MISSION, THE SOCIETY CONDUCTS HISTORICAL TOURS OF THE CAPITOL BUILDING, HOSTS BOTH VIRTUAL AND IN-PERSON PUBLIC HISTORY PROGRAMMING ON VARIOUS ASPECTS OF CAPITOL HISTORY, COORDINATES AN OPEN-ACCESS CIVICS EDUCATION HUB WHICH INCLUDES HISTORICAL PLAYS WITH LESSON PLANS, MANAGES A RENOWNED CIVICS EDUCATION FIELD TRIP PROGRAM FOR DC SCHOOLS, COMMISSIONS WORKS OF FINE ART FOR THE CAPITOL COLLECTIONS, AND SELLS HISTORICAL PUBLICATIONS AND COMMEMORATIVE ITEMS.

THIS TOUR, PROVIDED AT NO COST TO TITLE I DC PUBLIC AND CHARTER SCHOOLS, DEMONSTRATES TO STUDENTS FROM ALL WALKS OF LIFE THAT EVERYONE HAS A ROLE TO PLAY IN AN INCLUSIVE DEMOCRACY. DURING THE PANDEMIC WHEN IN-PERSON TOURS WERE NOT SAFE THE SOCIETY CREATED A DIGITAL RESOURCE HUB TO BRING TOGETHER IN ONE PLACE VIRTUAL TEACHING RESOURCES FOR TEACHERS. THIS VIRTUAL EDUCATIONAL HUB INCLUDES RESOURCES FROM THE NATIONAL PARK SERVICE, THE WHITE HOUSE HISTORICAL ASSOCIATION, THE NATIONAL ARCHIVES, THE U.S. CAPITOL VISITOR CENTER AND THE SUPREME COURT HISTORICAL SOCIETY AND CONTINUES TO GROW.

IN ADDITION TO OUR EDUCATIONAL TOURS, THE SOCIETY PARTNERS TO BRING THE HISTORY OF OUR REPUBLIC TO LIFE VIA THE ARTS. WE HAVE THREE PLAYS ON OUR HUB, BEAUTIFUL AGITATORS, DESIGNED TO TEACH HOW THE CONSTITUTION INSPIRED THE CIVIL RIGHTS MOVEMENT, NOW'S THE TIME, EXPLORING THE END OF RECONSTRUCTION THROUGH THE EYES OF CONGRESSMAN THADDEUS STEVENS, AND ELECTIONLAND, WHICH TELLS THE STORY OF THE FATEFUL ELECTION OF 1876 AND THE ENSUING DRAMA OF THE ELECTORAL COMMISSION OF 1877. ALL THREE ARE PRODUCED BY STORYWORKS THEATER COMPANY AS PART OF OUR TEACHING THE CONSTITUTION THROUGH THEATER PARTNERSHIP. THE STAGE PRODUCTION AND CORRESPONDING LESSON PLANS ARE FOUND ON THE DIGITAL RESOURCE HUB OF THE

FINALLY, THE SOCIETY'S PUBLIC HISTORY SERIES CONTINUES TO PROVIDE AUTHORS AN OPPORTUNITY TO PRESENT THEIR BOOKS AND SCHOLARS THE CHANCE TO SHARE THEIR PERSPECTIVE ON THE HISTORY OF THE CAPITOL AND THE CONGRESS. PRIOR SESSIONS INCLUDED A SIX-PART SYMPOSIUM ON THE IMPACT OF WOMEN EARNING THE RIGHT TO VOTE, A TEN-PART SYMPOSIUM ON THE WORK TO BUILD A MORE PERFECT UNION, AND CURRENT PUBLIC HISTORY WEBINARS EXPLORING THE AMENDMENTS TO THE CONSTITUTION - WHAT WAS THE CONTEXT WHEN THEY WERE ADOPTED AND HOW EACH AMENDMENT HAS BEEN INTERPRETED. ALL PROGRAMS ARE RECORDED AND AVAILABLE AT NO COST ON OUR YOU TUBE CHANNEL.

ALL OUR EVENTS REMAIN ON OUR WEBSITE FOR VIEWING BY INTERESTED PARTIES.

IN FEBRUARY 2025, THE SOCIETY HOSTED ITS SIGNATURE, BIENNIAL PROGRAM TO HONOR EACH NEW CONGRESS. THE PROGRAM HONORING THE 119TH CONGRESS FEATURED A KEYNOTE LECTURE BY HISTORIAN DR. DAVID GREENBERG, AUTHOR OF THE RECENT ACCLAIMED BIOGRAPHY JOHN LEWIS: A LIFE. LONGTIME ABC NEWS JOURNALIST KATHLEEN MATTHEWS MODERATED A PANEL WITH U.S. REPRESENTATIVE MARLIN STUTZMAN (R-IN), FORMER U.S. REPRESENTATIVE TOM REED (R-NY), AND 36TH CLERK OF THE U.S. HOUSE CHERYL L. JOHNSON, IN WHICH ALL DISCUSSED THE LESSONS THEY LEARNED FROM THE LATE CONGRESSMAN LEWIS DURING THEIR SERVICE IN THE CAPITOL. MORE THAN 200 PEOPLE PARTICIPATED IN THE EVENT HELD IN NATIONAL STATUARY HALL, AND COUNTLESS MORE HAVE VIEWED THE C-SPAN'S AMERICAN HISTORY TV.

THE SOCIETY CONTINUED ITS KEY EDUCATION PROGRAM, CAPITOL CIVICS, WHICH PROVIDES TEACHER INSTITUTES DESIGNED TO BRING EDUCATORS TOGETHER TO DISCUSS HOW TO USE PRIMARY RESOURCES IN THE CLASSROOM TO TEACH CIVICS. FOLLOWING AN INITIAL INVESTMENT FROM A CONGRESSIONAL APPROPRIATION ADMINISTERED BY THE NATIONAL ARCHIVES AND RECORDS ADMINISTRATION, WHICH ALLOWED THE SOCIETY TO PROVIDE TWO TEACHER INSTITUTES IN 2024, THE SOCIETY SECURED A TEACHING WITH PRIMARY SOURCES GRANT FROM THE LIBRARY OF CONGRESS TO CONDUCT ANOTHER WORKSHOP IN 2025.
